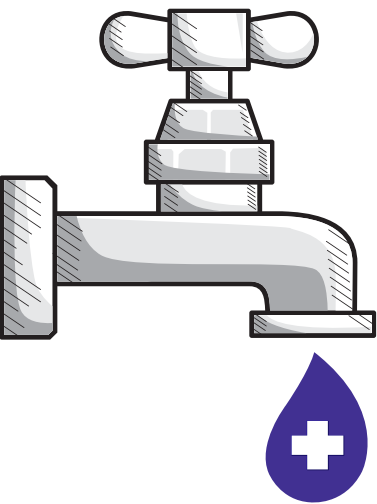

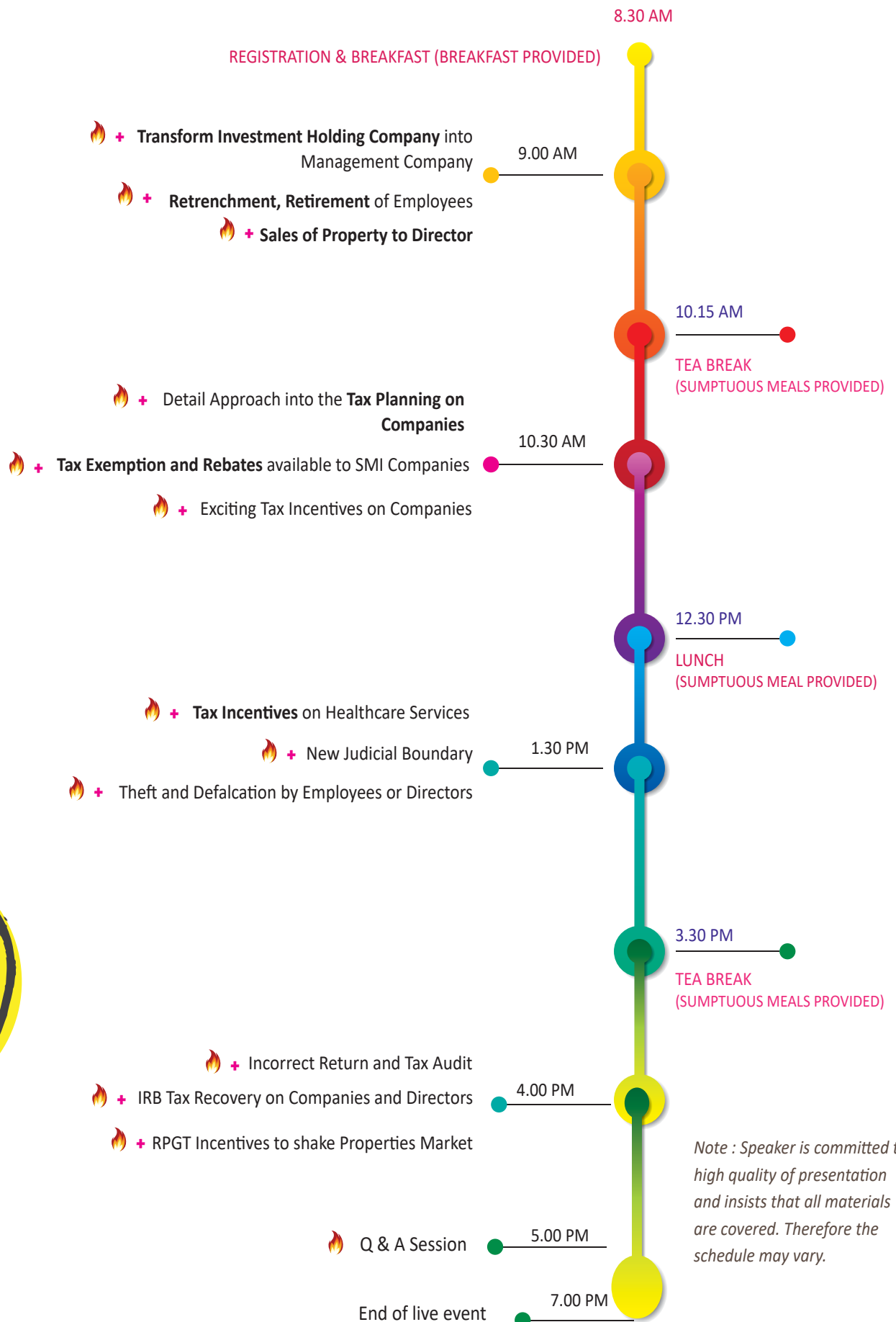

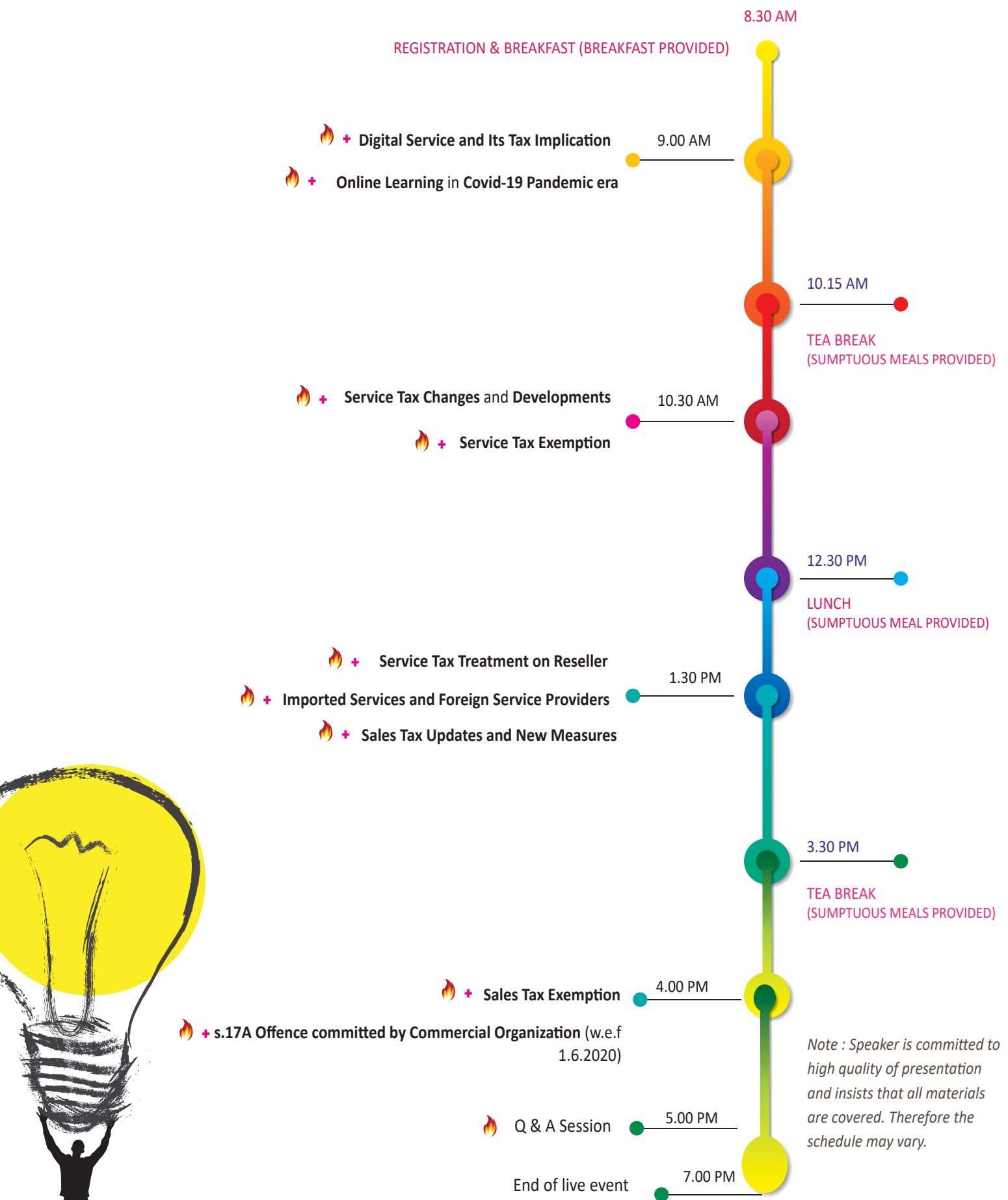
Presenting the Big Idea in Tax Planning.
